EXPRESSION OF INTEREST DOCUMENT

For taking up fish culture in cages in selected Water bodies of Karnataka State.

1. Introduction

Cage Culture is an emerging technology for intensive production of fish and is considered to have huge potential for increasing the fish production of the country. It is considered as the future of Indian Fisheries. In recent years, efforts are being made to promote cage culture in the inland open water bodies like reservoirs, flood plain, wetlands in the country. With this backdrop, Department of Fisheries, Government of Karnataka intends to lease out selected water bodies of the state to interested persons to take up fish culture in cages with the following objectives.

- 1) To augment fish production from Water bodies in a responsible manner, without affecting the livelihood of the traditional/local fishing communities.
- 2) To increase per capita fish protein availability in the state:
- 3) To enhance the income and livelihood security of the fishers depending on inland fisheries resources: and
- 4) To ensure that the growth of aquaculture is
 - a) Inclusive and sustainable,.
 - b) In harmony with principles of ecological integrity and natural resource conservation and
 - c) Not in conflict with the genuine interest of other users of the water and land resources.

The inland cage culture is currently being implemented in an isolated manner in various states with varying degree of success. Recognizing the high potential in cage culture, the activity has been included as a priority item under Pradan Mantri Mathsya Sampad Yojana and Department of Fisheries, Government of India has formulated an action Plan for implementation of Cage Culture. Accordingly Karnataka state Fisheries Department has made an action plan of establishing 100 cages in selected Water bodies of the state. Department of fisheries intends to select beneficiaries through EOI. The selected beneficiary has to follow and adopt guidelines for cage culture in inland open water bodies approved by NFDB. The selected beneficiary will be considered for availing financial assistance from Government of India.

2. Details of water bodies of Karnataka State proposed for taking fish culture in cages.

Department of Fisheries has the right to include or exclude the water bodies depending upon the demand and suitability.

3. Submission of DPR and evaluation

Individual/agency/firm/company shall have to submit DPR and formulate implementable cage culture project in the selected reservoir. Department of Fisheries has no role in facilitating the land for the need based ancillary units proposed for the project. Entrepreneurs may adopt innovative technologies of cage farming with the approval of the Department or may come up with their own technical specifications and design, Feasibility studies, time line of the project, implementation strategy, and detailed cost estimates, quotations, technical, financial, economic aspects and anticipated output and outcome of the project etc are needed to be furnished in the DPR. Entrepreneur need to submit the detailed project report as per the (format-4) along with application. Submitted applications will be scrutinized G.O empowered committee as approved in PA.sam.mi/10/mi.e.e/2015 shortlisted dt.06.02.2016 and applications will be placed before the state level committee for approval.

4. Patterns of Financial Assistance.

The successful applicant may avail financial assistance in accordance with the terms and conditions laid down in Central sector scheme on "Pradan Mantri Mathsya Sampad Yojana" Department of Fisheries will facilitate financial assistance for the project as per the norms of PMMSY guidelines subject to availability of funds and the rest of the project cost shall be borne by the successful applicant.

The government assistance is restricted to a maximum of 18 cages per individual beneficiary and in case of fisher SHGs/joint Liability Groups(JLGs)/Fisher co-operatives etc is restricted to a maximum of 72 cages per group at the rate of 6 cages per member of the group.

5. Implementation Module:

- Cages shall be installed in the selected reservoir of the state,
 Typically of 6m×4m×4m size up to maximum of 100 cages per unit.
- Entrepreneurs may come up with their own design, components, and innovative technologies, DPR shall be submitted to Department of Fisheries along with the application, Application and DPR will be evaluated by the empowered committee
- The entrepreneur shall adhere to the timeline stipulated by the committee for implementation of the project.

 On completion, team comprising officers from Department of Fisheries, Government of Karnataka and NFDB, Hyderabad will inspect, assess and recommend for release of subsidy.

6. TERMS OF REFERENCE (TOR)

6.1 Application Terms

- 1. The cage culture is a Lease Develop operate Basis.
- 2. Implementation model is specified as above (item 4) is subject to change as per the evaluation of DPR submitted by the applicant.
- 3. Processing fee of Rs.5000/- shall be paid through any nationalized bank through Demand Draft (DD) in the name of Director of Fisheries and Demand Draft should be enclosed with application.
- 4. Earnest Money Deposit (EMD) of Rs.50000/- (fifty thousand only) shall be paid through any nationalized bank through Demand Draft (DD) in the name of Director of Fisheries and Demand Draft should be enclosed with application.
- 5. Application without processing fee, EMD and incomplete applications will be summarily rejected.

6.2 Eligibility Criteria:

- 1. Applicant shall have a minimum experience of 3 years in large scale fish culture. Experience certificate from the concerned Deputy Director of Fisheries shall be submitted along with the application.
- 2. The applicant should have the financial capacity to invest a minimum of Rs.10 lakh. In this regard the applicant shall produce a solvency Certificate" for Rs.10 lakh from the bank.

6.3 Selection Criteria.

- 1. Empowered committee constituted as G.O.No.Pasammi/10/mi.e.e/2015 Dt;06.02.2016 will evaluate the applications and DPRs submitted by the applicants and shortlist the applicants for next stage of evaluation.
- 2. Shortlisted applicants will be invited to make a detailed presentation before the committee for further evaluation before finalizing the selection of entrepreneurs.
- 3. Based on the committee report, the selected candidates shall submit ``Request for proposal'' (RFP) for actual implementation of the project.
- 4. The decision of the committee members is final in the selection process.

6.4 RESERVOIR LEASE TERMS

- A maximum area of 0.25 ha area of particular reservoir will be leased to the selected entrepreneur to take up culture of fishes in cages for a minimum of 5 years and a maximum period of 10 years.
- 2. A Lease amount of Rs 10000 per annum has been fixed for 1st year. For the remaining years, lease amount shall be increased annually by 5 percent of the lease amount of the previous year or as prescribed by Government of Karnataka.
- 3. Successful applicant shall provide a Bank Guarantee of Rs.2.00 lakh to Department of Fisheries during the time of lease agreement.
- 4. Subleasing of the leased area is strictly prohibited.
- 5. Successful applicant shall pay the first year lease amount with Bank guarantee along with the signing of the

- agreement. Lease amount of the remaining years shall be paid in the beginning of the corresponding year and shall obtain renewal order from Department of fisheries.
- 6. The lessee should give minimum 50% of total requirement of the manpower of the project to the reservoir dependant people.
- 7. Department of fisheries shall have the power to cancel the lease if the proposed activities causes any violation of lease agreement or due to changes in Government Regulations with respect to reservoir management or any other environmental concerns or public interest activities in the location.
- 8. The leased site shall be utilized for fish culture in cages only. It shall not be used for any other commercial purposes like tourism or sports Fisheries etc. In such case lease will be cancelled.
- 9. The dumping, throwing of any type of wastages, dead fish or their viscera in to the water bodies which pollutes the quality of water shall not be allowed.
- 10. In case, any disease incidence is noticed in cages, all precautions should be taken to prevent and control it and the dead fish shall be disposed safely burying/burning them at a far-away place from the reservoir so that disease does not spread to the other cages or fishes in the water bodies.
- 11. The species of Fishes permitted by the Government of Karnataka only shall be reared in cages. If any illegal varieties or culture of banned varieties is noticed in the cages, lease shall be cancelled with immediate effect and

- shall attract legal measures from the concerned Department.
- 12. The selected entrepreneur shall take up culture of indigenous varieties or approved exotic varieties of fishes in the selected reservoir.
- 13. Department of fisheries shall not pay any compensation for any loss/damages caused due to any natural calamity or any other causes. The lessee alone will be responsible for any damage/loss incurred.
- 14. Financial assistance will be as per the PMMSY Norms.
- 15. Fish culture shall be taken up within 6 months after obtaining the unit on lease, otherwise lease will be cancelled.
- 16. Marketing of the fish produced from cage culture project is the sole responsibility of lessee.
- 17. Lessee shall provide information in stipulated format to Department of Fisheries regarding seed stocking, fish catch, marketing & income details of each crop.
- 18. Any issues regarding implementation of the scheme shall be sorted out by mutual discussion. In case of any irreconcilable differences, the decision of the Secretary/Principal secretary, Department of Animal Husbandry and Fisheries, Government of Karnataka shall be final and lessee shall abide by it.
- 19. Further disputes, if any arising out of the project will be settled within the jurisdiction of Bengaluru court only.

- 20. Officials of NFDB & Department of Fisheries, Govt. Of Karnataka shall have the access to the unit whenever required.
- 21. Department of Fisheries shall have right to cancel the lease if any of the above Terms of References found to be violated by the lessee.
- 22. Permission for cage culture will not be granted in the reservoir area coming under reserve forest, Wild life zone, national parks where public entrance is prohibited under any Government notifications or Law.
- 23. Successful applicant shall execute an agreement on Rs.200/- judicial stamp paper with Department of Fisheries stating that he/she abide by the above said terms and conditions.
- 24. The Lessee may use craft for to and fro movement of staff, feed and harvested fish from bank to project site.
- 25. The lessee shall not interfere or come in the way of other activities implemented in the reservoir.
- 26. The NFDB or State Government is in no way liable for the damages/compensation relief claimed by the individual /agency/firm/company to whom permission to install cages in the water body leased out is given.
- 27. The lessee is liable for payment of compensation to the reservoir fishermen in the event of indulgence in activities against to the interests of the reservoir fishermen.
- 28. The Lessee shall abide by the Terms and conditions stipulated periodically by the Central/State Government. The lease amount and Security Deposit shall be forfeited in

- case the lessee decides to discontinue the lease before completion of lease period.
- 29. Department of Fisheries has all the rights to modify any portion of EOI or withdraw or cancel the entire process at any stage during the process of implementation of the project.
- 6.5 Compliance to existing Govt. Notifications and guidelines.

The lessee shall abide by/comply the guidelines/Terms and conditions/clauses of the following Government notifications.

- While implementing the project, the First party will abide by the terms and conditions stipulated by the Govt. Of Karnataka vide G.O. No.Pasammi/125mi.e.e/2013 dated/21.02.2014
- 2. The guidelines published by Director of fisheries and Government of India on the Guidelines for cage culture in open inland water bodies of India.
