#### **INTRODUCTION:**

#### **Project Background & Brief Description**

The Government of Karnataka under Pradhan Mantri matsyasampada Yojana (PMMSY) has the approval of Gol for acquisition of Deep-sea fishing vessels for traditional fishermen.10 Nos of Deep sea fishing vessels at a Project cost of Rs.120.00 crore with 60:40 subsidy sharing pattern between Government of India and Government of Karnataka. The scheme will be implemented exclusively in the 3 coastal districts of Karnataka. The Standard Operating procedures (SoP) proposed and approved by Gol will be complied with to facilitate procurement of standardized Deep sea Fishing vessels (DSFV) under the PMMSY scheme.

#### **Project information**

The estimated unit cost of the new tuna longliner cum gill netter for deep sea fishing is Rs.120 lakh / boat. The Scheme will be implemented with the following funding pattern and subsidy assistance.

The financial assistance and beneficiary contribution shall be released in 4 stages to the designated bank account for the subsequent release of funds directly to the Boat building Yard/ Engine/ Equipment Suppliers.

# <u>Technical details/ requirements for the newly constructed deep sea tuna longliner cum gill netter fishing boats</u>

- 1. The DoF, GoI has issued the Approved Standardized DSFV Design and specifications (ASDDS). The ASDDS shall provide the minimum basic design parameters under which the vessel is to be constructed. DSFV's constructed in compliance of the ASDDS promulgated by the DoF, GoI shall be eligible for subsidy under the PMMSY scheme. The ASDDS for 3 types of vessel variants have been developed. The ASDDS details have been uploaded on the website of the DoF, Govt of Karnataka.
- 2. For construction of vessels with designs other than those published under ASDDS shall be technically vetted by CIFT and approved by IRS and built in yards qualified as per the SOP mentioned by GoI, in order to be eligible for PMMSY scheme.
- 3. The certification of vessel should abide by the certification process indicated in Annexure 2 of the SoP issued by GoI.
- 4. The subsidy assistance shall encompass the following major mandatory components.

#### Committees constituted for implementing this scheme.

The implementation of the scheme will be monitored by the following 3 committees constituted.

- 1. State Level Administrative Committee (SLAC)
- 2. State Level Technical Committee (SLTC)
- 3. Regional Scrutiny and Monitoring Committee (RSMC)

#### Release of Subsidy Assistance

- 1. The financial assistance upto 60% and 40% of the total eligible cost for women/SC/S and General category, respectively approved by the SLTC for all the eligible components as a whole.
- 2. The State Level Technical Committee (SLTC) is the competent authority to fix reasonable prices eligible for each mandatory component.
- 3. The subsidy assistance will be provided as 'Milestone based subsidy' and released in Four Stages as follows.

Stage 4	Commissioning of Engine, assembling of propelling unit, erection of Auxiliary engine, Gillnet hauler, line hauler and painting of outside hull should be completed. The beneficiary should sell the trawler outside Palk Bay Districts or Scrap the existing trawler and deregistration of the trawler shall be done. Fixing of communication equipment, Navigational equipment, registration of fishing vessels, launching and successful completions of sea trial (Engine, RSW, Navigational equipment and other equipment) and complete painting of the vessel. After the boat is handed over to the beneficiary, the final payments will be made. The boat shall be covered by an insurance policy by the beneficiary before taking delivery. 50% of beneficiary share should be deposited in the account as 3rd instalment.	30%

- 4. Every stage payment will be released by the State Level Administrative Committee (SLAC) based on the verification and recommendation of the Regional Scrutinizing and Monitoring Committee (RSMC).
- 5. On approval by the SLAC, the stage wise subsidy assistance will be credited directly to Savings Bank account created for the purpose of construction of the fishing boat and the same will be intimated to the beneficiary and the bank concerned.
- The Bank shall release the subsidy amount along with the corresponding institutional fund and beneficiary contribution to the vendor on obtaining required authority from the Deputy Director of Fisheries of the concerned district.
- 7. The Director Fisheries, Bangalore shall be the authority for redressal of any dispute arises between the parties concerned and his decision shall be final. If any violations are found, the Director of Fisheries shall stop the

- payment to any entity involved in this scheme with reasons to be recorded in writing.
- 8. The SLAC shall be appellate authority for any matter concerned with this scheme.

#### Time Line for Execution by the Boat Building Yards:

- 1. The Boat Building yard should initiate the construction of the boat within 15 days from the date of receipt of the work order. If the work is not taken up during the first inspection of the RSMC on the 15<sup>th</sup> day from the issue of work order, a show cause notice will be issued to state the reasons for not commencing the work within 7 days. If no reply is received, the work order shall be automatically terminated without any further notice.
- 2. The RSMC may extend another one week time to start the work, if the reason for not commencing the construction is justifiable. But the penalty clause for overall time limitation will be applicable.
- 3. In case of termination of the work order, The RSMC shall issue the work order to another boat building yard with the concurrence of the beneficiary.
- 4. The time limit for completion of the COMMISSIONING of deep sea fishing boat is NINE MONTHS FROM THE DATE OF RECEIPT OF THE WORK ORDER. If the construction of the boat and procurement of the gears etc., is not completed within the stipulated period the following penalty will be levied on the Boat building yard.
  - > 10<sup>th</sup> Month Rs.50.000/-
  - > 11<sup>th</sup> month Rs.1,00,000-
  - > 12<sup>th</sup> month Rs.2,00,000/-
- 5. The SLAC can modify the subsidy reduction based on the justifiable reasons if any given by the beneficiary.

#### Monitoring and Reporting:

- 1. The first inspection of the RSMC should be conducted on the 15<sup>th</sup> day from the date of issue of work order and intimate the commencement and progress of the work to the SLAC/ Director of Fisheries to release the 1<sup>st</sup> Stage subsidy.
- 2. On completion of each stage of the work as detailed above, the beneficiary/Boat Building Yard should intimate the same to the RSMC for inspection.
- 3. The RSMC will inspect the construction of the boat periodically.
- 4. The Committee should monitor the progress of the work in accordance with the design approved by the SLTC. If any deviation is noticed, the RSMC should incorporate the same in the inspection report with documentary evidence.
- 5. The RSMC should forward the proposal along with inspection report, stage completion report with the documentary evidences and specific recommendations to the SLAC for release of stage wise eligible subsidy assistance.

- 6. Based on the recommendations/ inspection report, completion certificates, photographs of various stages of boat construction and Specific recommendations, the SLAC will verify the report of RSMC and release of stage payment as front ended subsidy assistance.
- 7. The SLAC may depute a special team to conduct the check of the Boat construction and design etc., and verify the documents if need be.

#### **Other Conditions**

- 1) The New deep sea fishing boats should be constructed only at the empaneled boat building yards.
- 2) If at any circumstances, the intended beneficiary is not in a position to make his contribution on completion of the second stage, the SLAC shall take appropriate decision to allot the boat to another eligible beneficiary

- iii. Stability verification and final stability documents endorsement.
- iv. Witnessing of the inclining experiment or draught survey by IRS.
- v. Witnessing of the sea trials and functioning of main engine, propeller, rudder, steering gear, bilge pump etc.
- vi. Final commissioning of fish handling equipment and refrigeration solutions shall be done in the presence of IRS or CIFT representatives.

#### **BIDDING PROCEDURE:**

- The Prospective bidder may be a single entity or consortium of members not exceeding three (3) (referred to as "Bidding Consortium) coming together. Thus the term used "Bidder" hereafter would therefore apply to both a single entity and a consortium. The purchaser of this EOI document should be the single bidding entity or any one of the members of the Bidding Consortium.
- 2. The EOI document submitted by a Consortium should comply with the following additional requirements
  - Number of members in a consortium should be limited to 3 (three)
  - 2. The EOI should contain the information required for each member of the consortium.
  - 3. The EOI should include a description of the roles and responsibilities of individual members of the consortium.
- 3. Any business entity which has been barred by International Councils, Government of India, Government of Karnataka or any other State Governments or any of their agencies from participating

- in similar projects, and if the bar subsists as on the EOI due date, would not be eligible to submit an EOI, either individually or as member of a consortium.
- 4. An individual member applying as a sole bidder cannot at the same time be member of any consortium applying for this project. Further, a member of a particular consortium cannot be a member of any other Consortium applying for this project. Any member who submits or participates in more than one bid for this project will be disqualified and will also lead to disqualification of the Consortium of which it is a member.

## **Pre submission Meeting**

5. Pre submission meeting will be held on 10.01.2022 at 11.00 hrs at the Office of the Director of Fisheries, Bangalore with the interested bidder for discussion on development envisaged by the Director of Fisheries. Bidders are invited to give their suggestions and recommendation on the scope identified by Director of Fisheries to be developed. However the Director of Fisheries reserves the right to consider the suggestion and recommendations of the bidder or reject the same.
